

# **Upcoming LNA Training**

The course will meet Tuesday, Wednesday, and Thursday, 3:45pm - 8:45pm from **November 28, 2023 - January 25, 2024** (8 weeks of class; holiday break is Friday, December 22 - Monday, January 1). In addition, there will be a CPR and First Aid certification class scheduled at Rescue that must be attended. **The cost of this 126-hour course is \$2000.** You are advised to seek **financial aid**/support through VSAC (for VT students), support organizations, your employer, or you can self-pay.

The texts and **licensing exam fee** <u>ARE</u> **included** in the cost of the program; however, the **license** application fee and fingerprinting costs **are NOT included**. The licensing test date will be scheduled and announced after the class starts.

- SPACE AVAILABLE BASIS—high school students have priority for seats
- Current cost is \$4000 for a full-year day program, if student has a diploma or GED; payment source must be confirmed prior to program start date
- Adult application opens in May
- Adult will be contacted to meet with adult ed coordinator then the program instructor (hopefully before school gets out; if apply during summer, will need to meet when school starts)
- If adult is determined a good fit for day program, adult participation will be confirmed in August (as high school students continue to make schedule changes through the summer)
- Adult is expected to adhere to all high school and program protocols and expectations
- Consistent attendance and positive class participation is required
- All students in programs must pass the program's safety requirement within the first semester in order to continue
- Industry recognized credentials and certifications vary by program
